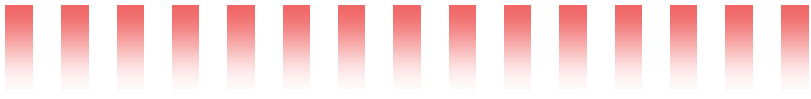


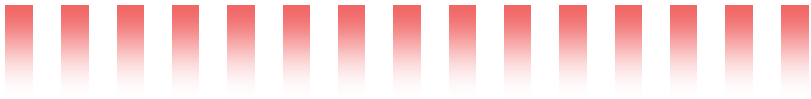

Background of the Foundation

The Missouri Retired Teachers Association authorized the formation of the Missouri Retired Teachers Foundation in 2002. The Foundation is a tax-exempt not-for-profit organization devoted exclusively to carrying out certain charitable, educational, scientific and literary purposes which include the following:

- To foster a spirit of respect, loyalty, and enthusiasm among retirees.
- To conduct activities and service projects which advance the cause of public education and the teaching profession in Missouri.
- To award grants and scholarships to students enrolled in teacher education programs, to active teachers and to support personnel to extend their professional training.
- To perform other humanitarian endeavors



The Foundation is incorporated under the laws of the State of Missouri and approved by the Internal Revenue Service as a public charity. All contributions and gifts to the Foundation from individuals, firms, associations, and other organizations are tax deductible for both income tax and gifts from estates. Independent financial audits are performed each year to ensure contributors that the funds are properly accounted for and being used consistent with the Foundation's purposes.

The Foundation's Bylaws and Articles of Incorporation were developed and officially approved by the Missouri Retired Teachers Association Executive Committee. The business activities of the Foundation are conducted by the MRTF Board of Directors.

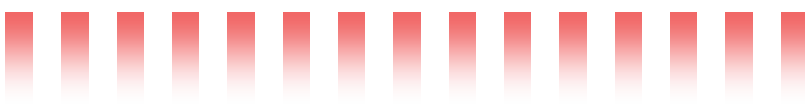
Projects of the Foundation

SCHOLARSHIPS

In 2002, the Foundation Board approved a New Teacher Scholarship Program awarding scholarships and grants. Scholarships will be awarded to active teachers or to students officially enrolled in a teacher education program and who are committed to teaching in Missouri schools. After advertising the scholarship program to all 49 colleges and universities in Missouri offering a teacher education program, 95 applications were received. On March 22, 2005, ten scholarships in the amount of \$1000 each were awarded at the MRTA Spring Leadership Workshop. Also three grants in the amount of \$500 each were awarded to three applicants from a field of 21 applicants. Grant money is used by active classroom teachers to fund classroom projects. The Scholarship Committee was chaired by Betty Beal with assistance from committee members Frieda Hornback, Barbara Maxwell, Marcia Slaughter, and Anna Lou Tommey. The scholarship program advances and enhances the status of the teaching profession in Missouri.

FIRST ANNUAL FUNDRAISING LUNCHEON

The Foundation's second annual fundraising luncheon was held on September 6, 2005 as a part of the MRTA Annual Meeting. Sixty-one people attended the luncheon, which provided approximately \$2000.00 in contributions. This amount was designated to the Building Fund. The keynote speaker was Former Governor Roger Wilson. Door prizes were awarded, and the luncheon proved to be a continued success both financially and in keeping with our mission of carrying out certain charitable, educational, scientific, and literary purposes such as conducting activities and service projects which advance the cause of public education and the teaching profession in Missouri. Fundraising luncheons will continue to be a part of the Foundation Board funding in the future.

MRTF BUILDING PROGRAM

The Foundation began a fundraising project for a permanent facility for MRTF and its sister organization, the Missouri Retired Teachers Association, in 2005. Since then it has purchased and paid for property directly across from its current office in Jefferson City. Together, they raised \$141,000 for that property which is two blocks from



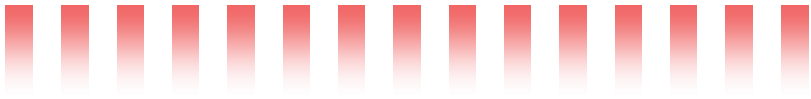

the PSRS/PEERS offices and two miles from the State Capitol Building. The early estimate for the Building Project is approximately \$450,000.

MRTF has had 10 retired educators who have designated their \$5000 death benefit to the Foundation's Building Fund. Members are encouraged to consider this option and leave a legacy of helping future retired educators and public education. All tax deductible donations to the MRTF Building Project are separate from the Scholarship/Grant Program and MRTA. This project is vital to MRTF's mission and vision statements. Having a permanent facility will ensure a positive future for Public Education Teachers/Employees. Its sister organization, MRTA, will be housed in the permanent facility allowing continuation of its tireless promotion and protection of the public school retiree and public education. This project will also include a Missouri Educator Hall of Fame. It will be one of only two in the nation and will honor those who have been instrumental in making Missouri Public Education one of the finest in the nation.

LABEL FUNDRAISING PROJECT

The Foundation is in the second year of an Address Label Campaign with all proceeds being designated to the MRTF Building Fund. In 2005, the Address Label Campaign generated \$75,000. The three-year campaign will generate funds in 2005–2007. Members receive mailing labels and are asked to donate \$10.00 each year or an amount of their choosing to support the Building Fund.

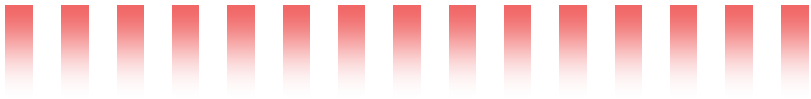
